Soon after the start Buckle Up Rose, Wynburn Jackson and Buckle Up Gina bumped, checking Wynburn Jackson. Shortly after Minto and Buckle Up Rose bumped, checking Minto. In the back straight Snowball Emma and Winkle Harry bumped, checking Winkle Harry. Approaching the first turn Wynburn Jackson and Buckle Up Rose bumped, checking Buckle Up Rose. On the first turn Snowball Emma and Wynburn Jackson bumped, checking Wynburn Jackson. Shortly after Snowball Emma and Buckle Up Rose bumped, checking both greyhounds. Buckle Up Rose underwent a post-race veterinary examination and no apparent injury could be detected.

### **RACE 2 – DOWLING MCCARTHY TYRES – GRADE 6 (2) – 452M**

Wynburn Ace was slow out. Soon after the start Buckle Up Clint, Buckle Up Blake and Times A Bonus bumped, checking Times A Bonus. In the back straight Wynburn Ace and Buckle Up Clint bumped. At the same time Kilty's Supreme checked off the heels of Sunnyside Up. Approaching the first turn Sunnyside Up galloped on the heels of Willie Win, checking both greyhounds. Shortly after Buckle Up Clint and Sunnyside Up bumped, checking both greyhounds. On the first turn Wynburn Ace and Willie Win bumped. Approaching the home turn Wynburn Ace and Willie Win bumped on several occasions. On the home turn Times A Bonus and Buckle Up Blake bumped. Shortly after Times A Bonus checked off the heels of Sunnyside Up. Entering the home straight Wynburn Ace and Kilty's Supreme bumped. Approaching the finish Buckle Up Blake and Willie Win bumped. Wynburn Ace underwent a post-race veterinary examination and no apparent injury could be detected. Steward's spole to Trainer Mr B Englund in relation to the race manner of Wynburn Ace rounding the first turn and approaching the home turn. Acting on their own observations viewing the official replays and taking evidence from Mr Englund, stewards were of the opinion that Wynburn Ace and Willie Win had bumped on a number of occasions and as a result Wynburn Ace had become unbalanced and shifted up the track. Under those circumstances stewards took no further action against the greyhound.

On the first turn Billy Mae, Rossa Rider, Princess Nevaeh, Red Power and Apocryphal bumped, checking Apocryphal, severely checking Princess Nevaeh which fell, checking Kao De Kahn. Approaching the home turn Rossa Rider checked off the heels of Red Power. On the home turn Billy Mae and Tiger bumped. Princess Nevaeh underwent a post-race veterinary examination which revealed the greyhound to have soreness to the neck and trapezius muscles. Princess Nevaeh has been stood down from racing for a period of 10 days. Kao De Kahn underwent a post-race veterinary examination and no apparent injury could be detected.

### **RACE 5 – SYNECTIC DEVONPORT – GRADE 5 (1) – 452M**

Soon after the start Prancing Black and Lucy's Locket bumped. Approaching the first turn Lucy's Locket, Prancing Black and I'm Mad bumped, checking Prancing Black. On the first turn Buckle Up Maria checked off the heels of Buckle Up Glad. At the same time Lucy's Locket and Prancing Black bumped. Approaching the home turn Buckle Up Maria and Ricson Flyer bumped. Approaching the finish Prancing Black and Buckle Up Maria bumped. Prancing Black underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr P Hili in relation to the race manner of Prancing Black over the concluding stages. Acting on their own observations viewing the official replays and taking evidence for Mr Hili, stewards were of the opinion that Buckle Up Maria had shifted up the track slightly at the same time Prancing Black was angling down the track and as the two greyhounds bumped Prancing Black became slightly unbalanced. Stewards weren't comfortably satisfied that this constituted failing to pursue the lure, and took no further action against the greyhound other than to advise Mr Hili that Prancing Black's future performances would be monitored. Lucy's Locket underwent a post-race veterinary examination which revealed the greyhound to have a dislocated toe on the right hind paw. Lucy's Locket has been stood down from racing for a period of 14 Days.

As a result Eketahuna galloped on the heels of Dorans Destiny, checking both greyhounds. On the home turn Winklee Sandy contacted the rail and as a result checked off the heels of Foxbird De Kahn. Winklee Sandy underwent a post-race veterinary examination and no apparent injury could be detected. Dorans Destiny underwent a post-race veterinary examination and no apparent injury could be detected. Eketahuna underwent a post-race veterinary examination and no apparent injury could be detected. Foxbird De Kahn underwent a post-race veterinary examination and no apparent injury could be detected.
