### **RACE 1 – THE MERCURY – GRADE 6(1) – 461M**

Major Mint and Winkle Harry were slow out. Soon after the start Koko and Buckle Up Demi bumped. Buckle Up Blake, Winkle Harry, Kreuzberg and Kilty's Supreme raced wide in the back straight. Approaching the first turn Kreuzberg and Kilty's Supreme bumped. At the same time My Call, Koko and Buckle Up Demi bumped. On the first turn My Call and Buckle Up Demi bumped checking Buckle Up Demi. Soon after Major Mint, Koko and Buckle Up Demi bumped. Winkle Harry, Kilty's Supreme and Kreuzberg raced wide around the first turn. Entering the home straight Buckle Up Demi and Kreuzberg bumped. Approaching the winning post My Call and Koko bumped. Koko underwent a post-race veterinary examination and was found to have soreness to the front of its right hock. Koko has been stood down from racing for a period of 5 days. Stewards spoke to trainer Mr A Bullock in relation to Koko's racing manners in the home straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Koko had eased and by doing so had failed to pursue the lure with due commitments throughout the event by reason of injury pursuant to GAR69B(1)(a). Koko has been stood down from racing until the completion of a satisfactory trial. A post-race swab sample was taken from Kilty's Supreme, winner of the event.

Approaching the home turn Billie Mae and Coasting Around bumped checking both greyhounds. On the home Painted Elvry and Ridgeview Ronda bumped. Painted Elvry raced wide in the home straight. Painted Elvry underwent a post-race veterinary examination and was found to have muscle soreness to its left thigh muscle. Painted Elvry has been stood down from racing for a period of 7 days. Stewards spoke to trainer's representative Mr B Pursell in relation to Painted Elvry's race manners racing around the first turn. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Painted Elvry had eased and by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR69B(1)(a). Painted Elvry has been stood down from racing until the completion of a satisfactory trial. Ridgeview Ronda underwent a post-race veterinary examination and no apparent injury could be detected.
