### **RACE 1 – AFTERNOON SHIFT INCAT – GRADE 6 – 340M**

Brindle Brae was slow to begin. Soon after the start, Raven Rich and Georgie bumped, checking Raven Rich. On the first turn, King Pierre and Red Orange Green bumped, checking Red Orange Green, Raven Rich and Brindle Brae. Soon after, Brindle Brae galloped on the heels of Raven Rich, checking Raven Rich. Newtown Flyer raced wide in the home straight.

### **RACE 2 – ALVERSTOKE ENGINEERING – GRADE 6 – 461M**

Bluegrass Moss was slow to begin. Soon after the start, Major Mint checked off the heels of Fasika and crossed to the rail. In the back straight, Fasika and Sleater bumped on several occasions, and Sleater and My Call bumped. On the first turn, My Call checked off the heels of Sleater. Soon after, My Call checked off the heels of Rusty The Jett. At the same time Major Mint checked off the heels of Rusty The Jett, checking Pollination and as a result, Billy The Jett crossed wide severely checking Bluegrass Moss which stumbled and lost ground. On the home turn, Fasika and Sleater bumped, checking Sleater and checking Fasika which stumbled and lost ground. Fasika and Rusty The Jett then bumped, checking Rusty The Jett. In the home straight, Fasika crossed wide. Bluegrass Moss underwent a post-race veterinary examination and no apparent injury could be detected.

Soon after the start, Munson and Mouse Trap bumped. On the home turn, Millie Magna and Crazy Wolf bumped. Millie Magna crossed wide in the home straight. Reiki Master raced wide in the home straight.

### **RACE 4 – CWS LABOUR HIRE – GRADE 6 – 340M**

On the first turn, Fernando Rhythm and Kayda Romance bumped, checking Secret Puzzle. Approaching the home turn, Miss Greer and Jacks High bumped. In the home straight, Fernando Rhythm checked off the heels of Miss Greer, which was racing tightly to the inside of Jacks High. Approaching the winning post, Jacks High and Miss Greer bumped. Miss Greer underwent a post-race veterinary examination which revealed the greyhound to have minor spike wounds and muscle soreness to its right hind leg. Miss Greer has been stood down from racing for a period of 4 days. Stewards spoke to trainer Mrs Debbie Cannon in relation to the racing manners of Miss Greer in the home straight by turning its head outwards for a short distance, when racing to the inside of Jacks High. Acting on their own observations, viewing the official race replays and taking evidence from trainer Mrs Cannon, Stewards were of the opinion that Miss Greer had failed to pursue the lure with due commitment throughout the event by reason of injury. Acting under the provisions of GAR69B(1)(a) Miss Greer has been stood down from racing until the completion of a satisfactory trial.

### **RACE 5 – DIRECT ACCESS – GRADE 5 – 599M**

Metanoia Franko, Fancy Moss and Above time were all slow to begin. On the first turn, Tom Tom Drum and Wynburn Lucifer bumped, checking Wynburn Lucifer. Soon after, Buckle Up Jones and Urana Reale bumped. Soon after, Tom Tom Drum checked off the heels of Buckle Up Jones. Entering the back straight, Fancy Moss and Above Time bumped. Fancy Moss raced wide in the home straight.

On the first turn, Kalaway Cobs and Coasting Around bumped checking Kalaway Cobs. Soon after, Bee Rose and Zoprush bumped, checking Zoprush. On the home turn, Dahlhaus and Coasting Around bumped. A post-race swab sample was taken from My Bro Zorro, the winner of the event.

### **RACE 8 – SHIP BUILDERS UNION – GRADE 4 – 461M**

Soon after the start, Willie Mac and Jacks Missile bumped and Seaside crossed to the rail. In the back straight, Tip It Up and Jack's Missile bumped. On the first turn, Lucky Linc checked off the heels of Tip It Up and lost ground. Lucky Linc underwent a post-race veterinary examination and no apparent injury was detected.

### **RACE 9 – TEAM CAT – GRADE 5 – 461M**

Soon after the start, Family Bruiser and Dolly Does It bumped. In the back straight Faboom and Family Bruiser bumped on several occasions. Approaching the first turn, Regent Lois and Jetta Jam bumped. On the first turn, Faboom and Family Bruiser bumped, checking Family Bruiser. Approaching the home turn, Burton Mercer checked off the heels of Faboom. Tah Jen raced wide in the home straight.

**RACE 10 – V/MAC LABOUR HIRE – GRADE 5 – 461M**

Dark Drifter and Nekhbet bumped in the back straight. On the first turn, Enfield Lynx and Dark Drifter bumped, checking Rikitikitana, Nekhbet and Billy Mae. Soon after Rikitikitana and Nekhbet bumped, checking Swaggart and Nekhbet which stumbled and fell as a result. In the home straight, Dark Drifter marred the running of Cotchin when racing to the outside of that greyhound and both greyhounds then bumped. Approaching the winning post Dark Drifter and Cotchin bumped. Nekhbet underwent a post-race veterinary examination and no apparent injury could be detected. Dark Drifter underwent a post-race veterinary examination and was found to have an injured left shoulder and muscle soreness and has been stood down from racing for a period of 3 days. Stewards spoke to trainer Mr Rodney Walker in relation to the racing manners of Dark Drifter in the home straight. Acting on their own observations, viewing the official patrol films and taking evidence from Mr Walker, Stewards were of the opinion that Dark Drifter had marred the running of Cotching by making head and muzzle contact when racing to the outside of that greyhound in the home straight. Acting under the provisions of GAR69(2)(a) Dark Drifter has been stood down from racing for a period of 28 days at Hobart only and until the completion of a satisfactory trial. A post-race swab sample was taken from Scrappy Doo the winner of the event.

**General:**

Koko completed a Stewards satisfactory trial over the 461 metre trial distance, as it had been stood down at HGRC meeting on the 8<sup>th</sup> of February 2018 for failing to pursue by reason of injury pursuant to GAR 69B (1)(a). Weighing 26.5kg and beginning from box 3 Koko completed the 461 metre trial distance finishing 2<sup>nd</sup> in a time of 26.79. Koko has been cleared to race at all tracks. A post-trial swab sample was taken from Koko.
