### **RACE 1 – CITY OF LAUNCESTON MAIDEN 3YO & UP – 1200 METRES**

**Lesnar (John Robertson)** – Proved difficult to load. A warning was placed on the gelding for its barrier manners. Had to be restrained approaching the 800 metres.

**Shackley's Hill (Dylan Caboche)** – Bumped on jumping and then shifted out quickly.

**Rogue One (Teagan Voorham)** – Apprentice T Voorham was spoken to regarding allowing her mount to shift in near the 1000 metres and advised she must afford runners to her inside more room in future.

**Mystic Molly (Nikita Beriman)** – Raced wide throughout.

**Orange Encounter (Anthony Darmanin)** – Connections advised that the mare would be ridden further back with cover today. Jumped away awkwardly then shifted in. Raced greenly and near the 1000 metres steadied and tightened.

**Southern Belle (Trent Germaine)** – Apprentice T Germaine was dislodged in the mounting yard prior to the event. He was examined by the on-course medical officers and passed fit to fulfil his engagement.

**Gee Gees Liberty (Craig Newitt)** – Over raced in the early and middle stages.

**Luvahussy (Hayley McCarthy)** – Commenced awkwardly and then shortly after restrained. Over raced in the early and middle stages.

### **RACE 2 – KACHOO APPRENTICE SERIES MAIDEN/CLASS – 1600 METRES**

**Lord Derby (Anna Jordsjo)** – Apprentice Jordsjo advised that the gelding raced well in the early and middle stages but when placed under pressure approaching the home turn did not stretch out fully and commenced to lay out. A post-race veterinary examination revealed no obvious abnormalities.

**Double You Tee (Chris Graham)** – Near the 500 metres had to be restrained when disappointed for a run between **Modern Dane** and **Datuk Zadrakon** which shifted out slightly.

**Kandahar (Mikaela Lawrence)** – Commenced awkwardly and bumped with Bad Luck. Carried wide at the 800 metres.

**Dubbo (Fiona Bell)** – Bumped on jumping.

**His Nibs (Sherry Barr)** – Bumped on jumping and restrained.

**Modern Dane (J Van Overmeire)** – Raced wide without cover throughout.

**Sunset Party (Quayde Krogh)** – Held up rounding the home turn.

**Teddy's Fault (Trent Germaine)** – Slow into stride.

**Bad Luck (Leticia Griffin)** – Raced wide without cover in the early and middle stages.

### **RACE 3 – TOUR DE CURE CLASS 3 HANDICAP - 1200 METRES**

**By The Pound (Andrew Mallyon)** – Reared on jumping. Rider A Mallyon advised that after rearing at the start the gelding was consequently placed further back than anticipated.

**Cranbrook (Craig Newitt)** – Commenced awkwardly then steadied. Approaching the 800 metres when racing greenly checked off the heels of Mariah's Magic and brushed with Vengeance Of Fury. Held up rounding the home turn.

**Son Of A Fling (Dean Yendall)** – Raced wide throughout.

**Osborne (Sherry Barr)** – Slow into stride.

**Vengeance Of Fury (Anna Jordsjo)** – Commenced awkwardly.

**Top Draw (Teagan Voorham)** – Lay in significantly over the final 200 metres and Apprentice T Voorham was unable to ride the gelding out. Trainer J Blacker advised Stewards that he would reassess the head gear on the mare prior to the next start.

### **RACE 4 – NATIONAL APPRENTICE SERIES HEAT 1 BENCHMARK 58 HANDICAP – 1400 METRES**

The start was delayed when **Lonhwan**, after being loaded into the barriers reared striking its head on the barrier stalls. **Lonhwan** was examined by the veterinary surgeon and found to be bleeding from both nostrils and was declared a late scratching at 2.31 pm.

**Bedrock Dreams** was unable to be loaded and was declared a late scratching at 2.32 pm. Prior to the announcement of correct weight Stewards ordered that all monies wagered on **Lonhwan** and **Bedrock Dreams** be refunded and all winning bets to be paid less 16 cents in the dollar on the face value of the ticket and 15 cents in the dollar on the face value of the place ticket.

**Don Reggio (Leticia Griffin)** – Raced with throughout.

**Oilly's A Star (Anna Jordsjo)** – Commenced awkwardly and bumped.

**Cranny Flyer (Mikaela Lawrence)** – Commenced awkwardly and then bumped with **Oilly's A Star**. Over raced in the early and middle stages getting its head up.

**Speckie (Jean Van Overmeire)** – Held up rounding the home turn.

**Bedrock Dreams (Lachlan Dodds)** – Declared a late scratching at 2.32 pm as it was unable to be loaded. Connections were advised that the mare must complete a satisfactory trial before racing again.

**Acronym (Trent Germaine)** – Reared on jumping away.

**Pelagia (Quayde Krogh)** – Near the 400 metres restrained when attempting a marginal run on the inside of **Tambro's Game**.

**Lonhwan (Chris Graham)** – Declared a late scratching at 2.31 pm. Connections were advised that **Lonhwan** must complete two consecutive satisfactory trials and submit a veterinary certificate of clearance prior to racing or trialling again. Trainer R Hamer advised Stewards that the gelding will now be retired.

#### **RACE 5 – SKY RACING BENCHMARK 72 HANDICAP – 2100 METRES**

**Geegees Baritone** – A post-race veterinary examination revealed no obvious abnormalities.

**Hugo (Teagan Voorham)** – Leaving the straight on the first occasion lay out getting its head up and having to be restrained.

**Smoke 'n' Whisky (Chris Graham)** – Over raced in the early and middle stages.

**Son Of Faith (Anthony Darmanin)** – Connections advised that the gelding will be ridden further back today if circumstances permit.

**Volcan de Fuego (Dean Yendall)** – Rider Dean Yendall pleaded guilty to a charge under AR 137A(5)(a)(ii) in that he used his whip on more than 5 occasions prior to the 100 metres and was subsequently fined \$500.

**It's A Battle (Craig Newitt)** – Brushed the running rail approaching the 400 metres.

#### **RACE 6 – BROOKLYN PARK AGISTMENT TASMANIAN OAKS 3YO FILLIES – 2100 METRES**

**Pateena Arena (Brendon McCoull)** – Lay inwards in the home straight.

**Casa de Lago (Billy Egan)** – Slow into stride.

**Heaven's Delight (Craig Newitt)** – Connections advised that the filly would be ridden further forward today if circumstances permitted.

**Clean Acheeva (Sigrid Carr)** – Unsettled in the barriers. Over raced in the early stages and lay out.

**Last Night (Andrew Mallyon)** – Shifted out on jumping away carrying Voices wider.

**Gone Girl (Jason Maskiell)** – Raced wide approaching the 500 metres.

**Voices (Anthony Darmanin)** – Fractious in the barriers prior to the start, and subsequently a warning was placed on filly. Laywards in in the home straight.

**Gwenville (Hayley McCarthy)** – Commenced awkwardly throwing its head in the air.

**Rodessa (Chris Graham)** – Raced wide throughout.

#### **General**

Rider B McCoull was examined by the on course medical officers following this race and passed fit to fulfil his engagements.

#### **RACE 7 – ARMIDALE STUD NEEDS FURTHER VAMOS STAKES – 1400 METRES**

**Gogo Grace (Dean Yendall)** – When being transported to the course the off hind plate was found to have shifted and was subsequently removed by connections and after arriving on course was replated and the mare subsequently passed a veterinary check. Raced wide from the 600 metres. When questioned Rider Dean Yendall explained that from the wide barrier he elected to settle the mare back in the field as he did not want to be caught wide. Passing the 600 metres when he placed the mare under pressure **Gogo Grace** failed to accelerate as expected and from there onwards lay out. A post-

race veterinary examination revealed the mare to be lame in the off hind leg. Trainer Mr L MacDonald was advised that a veterinary certificate of fitness must be submitted prior to the mare racing again.

**Step the Pedal (Andrew Mallyon)** – Held up rounding the home turn.

**Life On The Wire (Craig Newitt)** – Cast an off hind plate in running.

**Miss Two Pairs (John Robertson)** – Over raced in the early and middle stages.

**Catalyst Fire (Anthony Darmanin)** – Slow into stride.

**No Money No Honey (Troy Baker)** – Raced wide throughout.

#### **RACE 8 – TAS HOTEL & CATERING SUPPLIES BENCHMARK 78 HANDICAP - 1400 METRES**

**Silver Bolt (Chris Graham)** – Over raced in the early and middle stages. Lay in in the home straight.

**Harvey Bay (Teagan Voorham)** – Raced wide throughout. Over raced in the early and middle stages.

**Minute Repeater (Jason Maskiell)** – Rider J Maskiell was granted permission to ride ½ kg over the allotted weight (55.5kg). Raced wide from the 600 metres.
