Mendenhall was a late scratching at 11.45AM due to illness. Mendenhall has been stood down from racing for a period of 7 days pursuant to GAR37(2). Wicked Moss was slow out. Approaching the first turn, Winklee Harry checked off the heels of Sunnyside Up. Approaching the home turn, Wicked Moss and Sunnyside Up bumped. On the home turn, Wicked Moss checked off the heels of Sunnyside Up.

RACE 2 – GREAT NORTHERN SUPER CRISP CLASSIC HEAT 1 – MIXED 4-5 – 452M

Soon after the start, Crackenback, Fancy Moss and Gatwick bumped, checking Fancy Moss. Approaching the first turn, Crackenback and Muskett bumped. At the same time, Tynan and Relevance bumped, checking Relevance. On the first turn, Crackenback, Relevance and Muskett bumped, checking Relevance.

RACE 3 – GREAT NORTHERN SUPER CRISP CLASSIC HEAT 2 – MIXED 4-5 – 452M

Soon after the start, Monor Magic and Onassis bumped. Soon after, Pingles and Onassis bumped, checking Onassis. Approaching the first turn, Pingles and Perfect Nature bumped. On the first turn, Pingles and Minor Magic bumped, checking Minor Magic. At the same time Adam’s Spot checked off the heels of Manila Sal. Approaching the home turn, Buckle Up Gina checked off the heels of Adam’s Spot. On the home turn, Adam’s Spot and Manila Sal bumped. Approaching the winning post, Pingles and Manila Sal bumped, checking both greyhounds.

RACE 4 – GREAT NORTHERN SUPER CRISP CLASSIC HEAT 3 – MIXED 4-5 – 452M

A pre-race swab sample was taken from Miss Morvill. Soon after the start, Black Rhino, Yes Messi and Rockii De Kahn bumped. On the first turn, Black Rhino, Yes Messi, Miss Morvill and Wynburn Mustang bumped. On the home turn, Wynburn Mustang galloped on the heels of Yess Messi, severely checking Yes Messi and checking Black Rhino. Yes Messi underwent a post-race veterinary examination which revealed the greyhound to have a fractured right tarsal and was subsequently euthanised.

Soon after the start, Rusty The Jett and Buckle Up Dino bumped. In the back straight, Dyna Kungpow and Outa Manila bumped, checking Dyna Kungpow. On the first turn, Rusty The Jett crossed to the rails, checking Trumpence. Approaching the home turn, Cooper’s Shadow checked off the heels of Buckle Up Dino.

Approaching the winning post, Willie Mac checked off the heels of Amo Bailar.

RACE 8 – THE ADVOCATE – INV – 452M

Soon after the start, Cashmeera and Droopy’s Ella bumped, checking Droopy’s Ella. At the same time, Zipping Billy and Jake Sully bumped, checking Jake Sully. Approaching the first turn, Jake Sully and Falcie’s Dasher bumped. On the first turn, Cashmeera and Zipping Billy bumped, checking Cashmeera. Approaching the home turn, Jake Sully checked off the heels of Falcie’s Dasher. In the home straight, Jake Sully and Falcie’s Dasher bumped.

RACE 9 – GREAT NORTHERN SUPER CRISP CLASSIC HEAT 7 – MIXED 4-5 – 452M

Approaching the home turn, Hez A Bobby Dazzler, Buckle Up Blake, Nonchalant and Kiandra bumped, checking Buckle UP Blake. On the home turn, Nonchalant and Kiandra bumped.

RACE 10 – CARLTON DRAUGHT – GRADE 5 – 452M

A pre-race swab sample was taken from Wild Strike. Soon after the start, Tiger Mae, Wild Strike and Tecoma Skilda bumped. In the back straight, Frosty's Capable checked off the heels of Lektra Danger. Soon after Stylish April, Lektra Danger, Woodridge and Tiger Mae bumped, checking Stylish April and Tiger Mae. In the home straight, Woodridge and Medium Rare bumped. Soon after Medium Rare and Tecoma Skilda bumped. Approaching the winning post Medium Rare and Tecoma Skilda bumped. Stewards spoke to handler Ms I Watkins and Trainer Mr J Pringle in relation to Wild Strikes boxing manners in this event. Acting on their own observations, viewing the official patrol films and taking evidence off both participants, Stewards deemed that Wild Strike was difficult to box and has ordered that that greyhound be boxed first in future events pursuant to GAR52(1).

General:

Lyncar Teagan undertook a satisfactory stewards trial as it has not started in an even for a period of in excess of 6 months pursuant to LR31.3. Lyncar Teagan, who weighed 29.0 kg and began from box 5 was not cleared for this trial as the greyhound eased soon after the start and as a result did not finish the event. Lyncar Teagan underwent a post-trial veterinary examination and no apparent injury could be detected.
