South Serpent was slow out. Soon after the start Fishing Ducks stumbled and lost ground. At the same time Blazin' Stripes and Trumpence bumped. In the front straight Savatag and Lisa's Dream bumped. Approaching the first turn Trumpence, Kinloch's Fox and Malawi Breeze bumped checking Kinloch's Fox. Shortly after Lisa's Dream checked off the heels of Savatag checking Blazin' Stripes, Trumpence, Malawi Breeze and Kinloch's Fox. On the first turn South Serpent and Blazin' Stripes bumped. On the home turn Sacred Way and Little Loony bumped checking Little Loony which contacted the rail. Approaching the finish Havin' A Go, Coasting Around and Buckle Up Rose bumped. Double Day raced wide in the home straight. Northern Tattoos underwent a post-race veterinary examination and no apparent injury could be detected. Little Loony underwent a post-race veterinary examination which revealed the greyhound to have a superficial graze on the upper left thigh, however no stand down period was applied. Sacred Way underwent a post-race veterinary examination which revealed the greyhound to have a minor graze to the inside of the left fore-carpal area, however no stand down period was applied.

In the back straight Lady Rappa and Hoity Toity bumped checking Hoity Toity. On the 5<sup>th</sup> turn Metanoia Franko checked off the heels of Lady Rappa. Entering the home straight Rosie Oh Rosie and Seaside bumped. Approaching the finish Rosie Oh Rosie and Seaside bumped. Inanna Star eased in the home straight. Inanna Star underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to the right shoulder. Inanna Star has been stood down from racing for a period of 7 days. Trainer Mr Peter Higgins was spoken to in relation to the race manner of Inanna Star in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Higgins, Stewards were of the opinion that Inanna Star had eased and in doing so had failed to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Inanna Star has been stood down from racing until the completion of a satisfactory trial. Lansley Angel underwent a post-race veterinary examination which revealed the greyhound to have mild soreness to the right wrist and a graze to the left stopper pad. Lansley Angel has been stood down from racing for a period of 7 days. A post-race swab sample was taken from Wynburn Lucifer, winner of the event.

Shortly after Buckle Up Demi checked off the heels of Fernando's Dream and bumped with Princess Nevaeh. On the first turn Jetta Jam checked off the heels of Buckle Up Demi checking Jack The Fipa. On the second turn Marteeny crossed toward the rail checking Princess Nevaeh and Call Me Charlie. Approaching the third turn Jacks High eased checking Fernando's Dream. On the third turn Marteeny eased. Approaching the home turn Jacks High marred the running of Marteeny hampering Buckle Up Demi. Shortly after Fernando's Dream eased, shifted wider on the track and bumped with Jacks High. On the home turn Call Me Charlie and Buckle Up Demi bumped checking Call me Charlie. Jacks High underwent a post-race veterinary examination and no apparent injury could be detected. Trainer Mr B Deverell was spoken to in relation to the race manners of Jacks High approaching the third turn and until the home turn. Acting on their own observations, viewing the official replays, and taking evidence from Mr Deverell, stewards were of the opinion that Jacks High had eased, turned its head outwards towards Marteeny and made head and muzzle contact with that greyhound and in doing so marred the running of that greyhound pursuant to GAR691. Acting under the provisions of GAR692A Jacks High has been stood down from racing for a period of 28 days at Launceston and until the completion of a satisfactory trial. Marteeny underwent a post-race veterinary examination and no apparent injury could be detected. Trainer Mrs R Johnson was spoken to in relation to the race manners of Marteeny rounding the third turn. Acting on their own observations, viewing the official replays and taking evidence from Mrs Johnson, stewards were of the opinion that Marteeny had eased free of interference and in doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR69A(1)(a). Acting under the provisions of GAR69A(2)(a) Marteeny has been stood down from racing for a period of 28 days at Launceston and until the completion of a satisfactory trial. Fernando's Dream underwent a post-race veterinary examination which revealed the greyhound to have soreness to the right gluteal. Fernando's Dream has been stood down from racing for a period of 10 days. Trainer Mr W Howells was spoken to in relation

to the race manners of Fernando's Dream approaching the home turn and entering the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Howells, stewards were of the opinion that Fernando's Dream had eased and turned its head outwards and shifted up the track towards Jacks High, rounding the home turn and in doing so had failed to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Fernando's Dream has been stood down until the completion of a satisfactory trial. Jetta Jam underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to the left hind tensor fascia muscle. Jetta Jam has been stood down from racing for a period of 10 days. Trainer Mr R Watts was spoken to in relation to race manners of Jetta Jam rounding the home turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Watts, stewards were of the opinion that Jetta Jam had momentarily turned its head outward, however due to the significant interference to this greyhound's outside, stewards took no further action other than to issue a warning against Jetta Jam. Call Me Charlie underwent a post-race veterinary examination which revealed the greyhound to have soreness to the left elbow. Call Me Charlie has been stood down from racing for a period of 7 days. Trainer Mr D Turner was spoken to in relation to the race manner of Call Me Charlie rounding the home turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Turner, stewards were of the opinion that Call Me Charlie had momentarily turned its head outward rounding the home turn, however due to the significant interference to that greyhound's outside, took no further action other than to issue a warning against the greyhound. A post-race swab sample was taken from Princess Nevaeh, winner of the event.
