QUALIFYING TRIAL – RACE 1

Amore was slow to begin. Soon after the start Cawbourne Dawnie and Monahan Lass bumped. In the back straight Cawbourne Dawnie and Monahan Lass bumped, checking Shaina Lass. On the first turn Cawbourne Dawnie and Stefan's Choice bumped. In the home straight Cawbourne Dawnie and Monahan Lass both raced wide. Shaina Lass underwent a post-race veterinary examination which revealed muscle soreness to its right shoulder and some minor abrasions to both front stopper pads. Shaina Lass has been stood down from racing for a period of 5 days.

QUALIFYING TRIAL – RACE 2

Makin' Us Paw was slow to begin. Soon after the start Burton Mercer and Bro Sam's Hook bumped, and Cosmicly Baroque and Tip It Up bumped. On the first turn Linda's Love eased and lost ground. Approaching the home turn Burton Mercer checked off the heels of Bro Sam's Hook. Cosmicly Baroque, Makin' Us Paw, Whip Carter, Time Away and Burton Mercer all raced wide in the home straight. Linda's Love underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer J Davies in relation to the racing manners of Linda's Love on the first turn. Acting under their own observations, viewing the official patrol films and taking evidence from Mr Davies, stewards were of the opinion that Linda's Love had visibly eased free of interference and of its own accord and in doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Acting under the provisions of GAR 69A(2)(a) Linda's Love has been stood down from racing for a period 28 days at Hobart and until the completion of a satisfactory trial.
