RACE 1 – GARRY & BEV FAHEY DIVISION 1 – GRADE J/M – 461M

The start of this race was delayed one minute due to a Sandown Greyhound Race running behind schedule. In the back straight Rip The Bandaid and Ten Bears bumped. On the first turn Thunder Punch galloped on the heels of Teflon, severely checking Teflon. Soon after Kel Knight and Teflon bumped, checking both greyhounds. Soon after Rip The Bandaid and Winsome Jesse bumped. Approaching the home turn Ten bears checked off the heels of Winsome Jesse. Teflon underwent a post-race veterinary examination which revealed muscle soreness to its left hind quadriceps. Teflon has been stood down from racing for a period of 10 days.

RACE 2 – IAN & KAY CALLINAN DIVISION 1 – GRADE 6 – 461M

In the back straight Lily Lola and Super Baroque bumped. On the first turn Lily Lola crossed wide checking Deni's Destiny. Soon after Deni's Destiny crossed wide. In the home straight Deni's Destiny raced wide. Deni's Destiny underwent a post-race veterinary examination which revealed minor abrasions to both its front stopper pads. Deni's Destiny has been stood down from racing for a period of 7 days.

RACE 3 – LYGON LEADER DIVISION 1 – GRADE M – 461M

Howie's Boy was slow to begin. In the back straight My Call and Kayda Romance bumped. Soon after Kayda Romance and Howie's Lioness bumped. On the home turn Shadow Blu marred the running of Lashing Blondie racing to it's outside and both greyhounds bumped on several occasions. Lashing Blondie and Howie's Boy raced wide in the home straight. Shadow Blu underwent a post-race veterinary examination which revealed muscle soreness to its left hamstring. Shadow Blue has been stood down from racing for a period of 14 days. Stewards spoke to trainer Mr Scott Fenton in relation to Shadow Blu's racing manners on the home turn, when racing to the inside of Lashing Blondie by turning it's head outwards and marring the running of Lashing Blondie. Stewards were of the opinion that Shadow Blu had marred the running of that greyhound pursuant to GAR69(1). Acting under the provisions of GAR69(2)(a) Shadow Blu has been stood down from racing for a period of 28 days at Hobart only and until the completion of a satisfactory trial.

Swisher was a late scratching at 7.51pm due to veterinary advice after it was revealed that the greyhound to be on season after being taken out of its kennel to be prepared for racing. Swisher has been stood down from racing for a period of 28 days. Soon after the start Whoop Bang and Miss Hanigan bumped. At the same time Gentle Flash and Izon Amy bumped. On the first turn Crazy Wolf and Kath Emery bumped. Soon after Gentle Flash crossed to the rail checking Millie Magna. Soon after Millie Magna and Izon Amy bumped.

RACE 5 – YOUNG O'REILLY DIVISION 1 – GRADE 5 – 461M

Amo Bailar was slow to begin. In the back straight Sacred Shadow and Manila Miss bumped. At the same time Like 'Em All and Amo Bailar bumped. On the first turn Militant and Manila Miss bumped. At the same time Sisco Rocco and Amo Bailar bumped, severely checking Militant. Soon after Sisco Rocco and Amo Bailar bumped, resulting in Amo Bailar falling, and as a result Manila Miss was checked. Amo Bailar which completed the course after falling underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Like 'Em All, third place getter of the event.

Soon after the start Silly Milly and Miny Mo bumped. Soon after Gambler's Loot and Silly Milly bumped. Soon after Cawbourne Dawnie and Miny Mo bumped. In the back straight Double Explosion and Silly Milly bumped. Soon after Silly Milly and Miny Mo bumped. On the first turn Gambler's Loot checked off the heels of Cawbourne Dawnie, checking Silly Milly and Miny Mo. Double Explosion and Cawbourne Dawnie raced wide in the home straight.

Soon after the start Dan Road crossed to the rail, checking Bro Sam's Hook. Approaching the first turn Rosie Oh Rosie and Bro Sam's Hook bumped. Soon after Country Shadow and Rosie Oh Rosie bumped, checking Rosie Oh Rosie. Soon after Bro Sam's Hook and Metanoia Franko bumped, checking Bro Sam's Hook. On the first turn Country Shadow and Bro Sam's Hook bumped. Approaching the home turn Bobby Bound checked off the heels of Hoity Toity. Cosmicly Baroque raced wide in the home straight. Bro Sam's Hook tired over the concluding stages. Metanoia Franko underwent a post-race veterinary examination which revealed muscle soreness to its left hind leg. Metanoia Franko has been stood down from racing for a period of 7 days. Bro Sam's Hook underwent a post-race veterinary examination which revealed muscle soreness to its left chest and left hind foot. Bro Sam's Hook has been stood down from racing for a period of 7 days. Rosie Oh Rosie underwent a post-race veterinary examination which revealed muscle sprain to its right wrist. Rosie Oh Rosie has been stood down from racing for a period of 10 days. A post-race swab sample was taken from Bobby Bound, winner of the event.

RACE 8 – STOMPY JONES DIVISION 2 – GRADE 5 – 461M

Mouse Trap was very slow to begin. On the first turn Medium Rare checked off the heels of Bluegrass Moss. Bluegrass Moss and Medium Rare bumped, checking both greyhounds. Approaching the winning post My Girl Margie and Landlord bumped. My Bro Zorro and My Girl Margie bumped.

RACE 9 – AMIN BABA DIVISION 2 – GRADE 5 – 340M

Little Bit Magic stepped and led, began smartly. On the first turn Sizzling Bandit checked off the heels of Gold Drift, checking Feel The Noise. Soon after Tah Bob and Suva bumped, checking Tah Bob and Storm Water. Soon after Gold Drift and Lucy's Locket bumped. Approaching the home turn Sizzling Bandit checked off the heels of Storm Water, checking Feel The Noise. Tah Bob and Feel The Noise both raced wide in the home straight. A post-race swab sample was taken from Little Bit Magic, winner of the event.

Paddy Flash and Domasco were both slow to begin. In the back straight Stylish Russell, Coasting Around and Double Truth bumped, checking Domasco and Paddy Flash, which lost ground as a result. On the home turn Double Truth and Domasco bumped.

General:

Dame Kirra completed a satisfactory stewards trial as it was stood down at the Hobart Greyhound Racing Club meeting on the 19th April 2018 pursuant to GAR69A(1) for failing to pursue. Weighing 26.7kg and beginning from box 3, Dame Kirra completed the 599m trial distance in a time of 35:33. Dame Kirra has been cleared to race all tracks up to a distance of 600m.

Suspect Nargles completed a satisfactory stewards trial as it was stood down at the Hobart Greyhound Racing Club meeting on the 1st March 2018 pursuant to GAR69A(1) for failing to pursue. Weighing 27.4kg and beginning from box 3, Suspect Nargles completed the 340m trial distance in a time of 21:61. Suspect Nargles has not been cleared as it failed to run the qualifying time.
