RACE 1 – QUALIFYING TRIAL 1

Howie's Boy was slow to begin. Soon after the start, Ridgeview Belle faltered and failed to complete the course. In the back straight Good Move and Bunna Boy bumped. On the first turn Howie's Boy and Willie Mac bumped, checking Howie's Boy. Soon after Toey Rocket checked off the heels of Howie's Boy, severely checking that greyhound. In the home straight Toey Rocket raced wide. Ridgeview Belle underwent a post-race veterinary examination which revealed muscle soreness to its right hind hamstring and adductor muscle. Ridgeview Belle has been stood down from racing for a period of 10 days. Stewards spoke to trainer Jason Barwick in relation to the racing manners of Ridgeview Belle in the back straight by faltering and failing to complete the course. Acting under the provisions of GAR69B(1)(a) Ridgeview Belle has been stood down until the completion of a Stewards satisfactory trial for failing to pursue by reason of injury.
