Approaching the home turn Mahjong Rule crossed wide. Entering the home straight Katy Bell checked off the heels of Iza Busy. In the home straight, Mahjong Rule raced wide. A post-race swab sample was taken from Settled, the winner of the event.

On the home turn, Stephan's Choice and Destini Duchess bumped, checking both greyhounds. Destini Duchess underwent a post-race veterinary examination and no apparent injury could be detected.

On the first turn, Hetti's Produce shifted up towards the centre of the track and lost ground. Approaching the home turn, Hetti's Produce crossed wide. In the home straight, Hetti's Produce raced wide. A post-race swab sample was taken from Flamin Baroque, the 3<sup>rd</sup> place getter of the event. Hetti's Produce underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness and bruising to its right hind gracillis muscle. Hetti's Produce has been stood down from racing for a period of seven days.

Soon after, Hardaway Hitman crossed wide and bumped with Whip Carter, checking Whip Carter and severely checking Hardaway Hitman. Both greyhounds lost ground as a result. On the home turn, Rookie crossed wide. Hardaway Hitman underwent a post-race veterinary examination and was found to have muscle soreness to its right hip and some minor toe bruising to its left hind foot. Hardaway Hitman has been stood down from racing for a period of 5 days A post-race swab sample was taken from Gold Drift, 3<sup>rd</sup> place getter in the event.
