Stewards spoke to Trainer Mr P Hilli in relation to the race manners of Elite Outa in the home straight. After viewing the official patrol films, taking evidence from Trainer Mr P Hilli and from their own observations, stewards took no further action, as they were unable to ascertain if head and muzzle contact had been made. However, Mr P Hilli was advised that stewards would be monitoring future race performances of this greyhound. A post race swab sample was taken from Decisions, winner of the event.

**RACE 5 – TRISTAN ANDERSON APPRECIATION – GRADE 5 – 600M**

Minto was slow out. Soon after the start, Times A Bonus and Cashmeera bumped. Soon after, Minto galloped on the heels of Times A Bonus, checking both greyhounds. Approaching the first turn, Settled, Jellybean Jones, Cashmeera and Reiki Master bumped, checking Cashmeera. Soon after, Cashmeera and Wynburn Phoenix bumped. Approaching the second turn, Jellybean Jones checked off the heels of Minto. On the third turn, Settled galloped on the heels of Mighty Nova, checking Mighty Nova. Approaching the fourth turn, Minto crossed to the

rails, checking Cashmeera. As a result, Jellybean Jones, Times A Bonus and Cashmeera were checked. On the home turn, Jellybean Jones and Wynburn Phoenix bumped.

Weighing 27.8kg and beginning from box 5 **Magpie Fencer** completed the 278 metre trial distance finishing 4th in a time of 16.98. **Magpie Fencer** has not been cleared as it did not run the qualifying time required.
