Approaching the home turn Travellin' Song and Fernie bumped checking Travellin' Song. Soon after Buckle Up Noah galloped on the heels of Travellin' Song checking both greyhounds. Approaching the winning post Buckle Up Sylvia checked off the heels of Flash Holly.

Soon after Buckle Up Ethan checked off the heels of Darunia, as a result Buckle Up Ethan and Buckle Up Laura bumped checking Buckle Up Laura. In the back straight Buckle Up Laura checked off the heels of Buckle Up Speri. Approaching the first turn Wicked Moss and Buckle Up Carter bumped checking Wicked Moss. On the first turn Buckle Up Laura checked off the heels of Buckle Up Ethan. Testa Dura underwent a post-race veterinary examination and was found to have mild abrasions to the right hind foot, however no stand-down period was applied. Stewards spoke to trainer Mr B Purcell in relation to the race manners of Testa Dura throughout the event. After taking evidence from Trainer Mr B Purcell, watching the official replays. Stewards took no further action. Stewards however placed a warning on the greyhounds racing manners and will monitor the greyhound's future performances.

The all clear in this event was delayed so Stewards could view the official patrol films in relation to the lure in particular in the home straight, acting on their own observations viewing the official patrol films, Stewards were satisfied of the consequence of such variance no greyhounds would be substantially inconvenienced so as to effect the outcome of the event. All clear on the judge’s numbers was given. Soon after the start Da Bont crossed to the rails checking Rockii De Kahn, Rikitikitana and Lethal Lomar. Soon after Lenard’s Boy and Major Mint bumped. Approaching the first turn Rikitikitana and Lethal Lomar bumped checking Lethal Lomar.

A post-race swab sample was taken from Posh Amber winner of the event.

General:

Trainer Mr J Wright was reprimanded pursuant to GAR33(4) in that he presented Liffey Falls to race without the registration certificate.

Ev’s Girl completed a Stewards satisfactory trial as it had been stood down at the North West Greyhound Racing Club meeting on the 4th September 2018 for marring in the event pursuant to GAR69(1). Beginning from box 3 and weighing 27.9kg, Ev’s Girl completed the 452m trial distance in a time of 26.2. Ev’s Girl has been cleared to race at all tracks. Ev’s Girl underwent a post-race veterinary examination after hitting the rail on the first turn and no apparent injury could be detected.

Buckle Up Tatum completed a Stewards satisfactory trial over the 452M trial distance after having been stood down pursuant to GAR69(1) for marring on the 31 July 2018 in Devonport. Weighing 31.2kg and beginning from box 3 Buckle Up Tatum completed the 452 m trial distance finishing 2nd in a time of 26.09. Buckle Up Tatum has been cleared to race at all tracks.

Buckle Up Nel completed a Stewards satisfactory trial over the 452M trial distance after having been stood down pursuant to GAR71 for unsatisfactory performance at the Launceston Greyhound Racing Club on the 2 October 2018. Weighing 27.9 kg and beginning from box 5 Buckle Up Nel completed the 452 m trial distance finishing 3rd in a time of 26.15. Buckle Up Nel has been cleared to race at Devonport only.

CHAIRMAN OF STEWARDS
