RACE 1 – CURTAINS & BLINDS – GRADE: 6 – 515M

Buckle Up Heidi was slow out. Soon after the start Buckle Up Kiona and Buckle Up Fred, checking Buckle Up Kiona. On the first turn Buckle Up Fred and Buckle Up Carter bumped. At the same time Buckle Up Kiona and Buckle Up Heidi bumped, checking Buckle Up Heidi. On the second turn Strap In faulted. Approaching the third turn Buckle Up Nola, Strap In and Buckle Up Fraya bumped, checking Strap In, Buckle Up Carter and Buckle Up Fred. On the the third turn Strap In and Buckle Up Kiona bumped. In the home straight Buckle Up Fraya and Buckle Up Ava bumped. Strap In underwent a post-race veterinary examination, which revealed the greyhound to have muscle soreness to its left hind quadriceps muscle. Strap In has been stood down from racing for a period of 10 days. Buckle Up Fred underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 4 – WINNING EDGE KIBBLE – GRADE: 5 (1) – 515M

Toey Rocket was slow out. In the front straight Midnight Special and Apocryphal bumped, checking Apocryphal. On the first turn Blazin' Stripes, Tenerife Sea and Hooltifa bumped, checking Hooltifa. On the second turn Tenerife Sea checked off the heels of Jamming Jmmy. In the back straight Toey Rocket checked off the heels of Tenerife Sea, checking Toey Rocket. Approaching the winning post Tenerife Sea eased. Tenerife Sea underwent a post-race veterinary examination which revealed the greyhound to have a torn right tensor fascia muscle. Tenerife Sea has been stood down from racing for a period of 14 days. Stewards spoke to trainer Mrs D Cannan in relation to Tenerife Sea's race manner over the concluding stages. Acting on their own observations, viewing the official replays and taking evidence of Mrs Cannan, Stewards were of the opinion that Tenerife Sea had eased approaching the winning line and by doing so had failed to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR 69B(1)(a). Tenerife Sea was stood down from racing until the completion of a satisfactory trial.

A post-race swab sample was taken from Buckle Up Rose, winner of the event.
