Comments / Explanations:

RACE 1 – JBS AUSTRALIA MADIEN – 1000 METRES

RISING HSIANG (R Mangan) was a late scratching @ 1.06pm when it became fractious enroute to barrier on a number of occasions and has been stood down until the completion of a satisfactory jump out.

The start of this event was delayed 7 minutes due to the late scratching of RISING HSIANG.

Prior to correct weight being declared, Stewards ordered all monies invested on RISING HSIANG to be refunded. All bets made prior to 1.06pm were to be paid less than 31 cents in the dollar on the face value of the win ticket and 28 cents in the dollar on the face value of the place ticket.

MINDY (J Letherby) – Difficult to load, slow into stride (1L) and failed to muster early speed. Race greenly throughout. A warning has been placed on the mare's barrier manners.

VALCURL (J Philpot) – raced keenly at the 750 metres.

RACE 2 – TOM WILSHIRE MEMORIAL CLASS B HANDICAP – 1000 METRES

SKWOSH (J Letherby) was a late scratching at 12.15pm on Veterinary advice after it was found to have a laceration and abrasions to its head sustained in the float whilst enroute to the track.

EX WORDS(R Mangan) – Slow into stride (2L).

THE WICKED WITCH (M Ulucinar) – Rider (Mehmet Ulucinar) on returning to scale reported that the saddle slipped at approximately 750 metres resulting in the rider having to take hold and lose considerable ground.

DEBSERAA (J Luxe) – Over raced and threw its head in the air in the home straight.

Jockey D SCHMITT pleaded guilty to a charge under AR145 in that he weighed in in excess of 1kg over the allotted weight. Jockey D SCHMITT was fined the sum of \$100.00.

RACE 3 – KING ISLAND BUTCHERY/EAT GROUP MADIEN – 1400 METRES

SHIVIDA (J Letherby) – Slow into stride (2L) raced 3 wide without cover from the 500 to the home turn.

SKIP (E Kacmaz) – Jumped the crossing at 1100 metres, tired from the 450M.

At the 450M lost considerable ground when jockey E Kacmaz lost his irons placing him at a disadvantage for the remainder of the race. Jockey Kacmaz was dislodged as he was unable to pull the horse up after passing the winning post and was examined by the on-course doctor and was passed fit to fulfil his remaining riding engagement.

SKIP - underwent a post-race veterinary examination, which failed to reveal any apparent abnormalities.

SEBRING STAR (D Schmitt) – over raced in the middle stages of the event. Raced three wide without cover nearing the 900M.

BRING ON FRIDAY (J Philpot) Fractious in barriers and was inconvenienced shortly after the start.

Jockey Rhonda Mangan was reprimanded under AR137(a) careless riding for shifting ground when insufficiently clear of JUDGE BURNS (M Ulcinar) at approximately the 450M. Jockey M Ulcinar was reprimanded under AR137(a) careless riding for shifting ground outwards and then shifting back in onto SKIP (E Kacmaz). Resulting in Jockey E Kacmaz checking his mount and losing his irons. In not taking further action stewards could not attribute the blame to any one rider.

RACE 4 – ELDERS RURAL CLASS A HANDICAP – 1400 METRES

DASHING DEVON (D Schmitt) – Slow into stride (1L)

TAKE ON ME (E Kacmaz) – Slow into stride (2L), slow to muster early speed.

SKYSHARK (J Letherby) – On returning to scale reported that at approximately near the 850M after racing tightly between Doin It Solo and Take On Me, improved in a forward position his saddle shifted sideways. Causing Jockey Jason Letherby to lose his irons and balance and falling from his mount. Jockey J Letherby was examined by the on course ambulance attendants and taken to hospital for further observation overnight. The gelding underwent a post-race veterinary examination, which failed to reveal any apparent abnormalities.
