Approaching the home turn Kreuzberg and Chill Winston bumped. On the home turn Kreuzberg and Chill Winston bumped, checking both greyhounds. At the same time Hit The Deck checked off the heels of Dan Lou. Kreuzberg raced wide in the home straight.

In the home straight Fabulous Diamond marred the running of Lily Lola. Dancing Barefoot underwent a post-race veterinary examination and no apparent injury could be detected. Fabulous Diamond underwent a post-race veterinary examination and was found to have split webbing to its right hind foot. Fabulous Diamond has been stood down from racing for a period of 14 days. Stewards spoke to trainer representative Mr R Stamford in relation to Fabulous Diamonds race manners over the concluding stages. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Fabulous Diamond had turned its head outwards and made head or muzzle contact to Lily Lola and by doing so had marred the running of that greyhound pursuant GAR69(1). Acting under the provisions of GAR69(2)(c), Fabulous Diamond has been stood down from racing for a period of 12 months all tracks and until the completion of a satisfactory trial.

On the first turn Zalaya, Miller's Gold and Ginger Nic bumped, checking Miller's Gold who fell, checking Greysynd Hawk. Soon after Greysynd Hawk checked off the heels of Ginger Nic. Miller's Gold underwent a post-race veterinary examination and was found to have a spike wound to its right hind foot. Miller's Gold has been stood down for a period of 7 days.

Inanna Star underwent a post-race veterinary examination and was found to have a severely torn right tensor fascia muscle. Inanna Star has been stood down from racing for a period of 21 days.
