Double Explosion and Cashmeera raced wide in the home straight. Post-race swab samples were taken from Huxley and Orson Allen, the winner of the event and second placegetter respectively.

Tenerife Sea completed a stewards satisfactory trial as it was stood down from the LGRC meeting on the 26<sup>th</sup> of November 2018 for failing to pursue the lure with due commitment throughout the event, pursuant to GAR69B(1)(a). Weighing 36kg even and beginning from box 5, Tenerife Sea completed the 461m trial distance on a time of 26.32. Tenerife Sea has been cleared to race all tracks except Launceston.
