### ***Comments / Explanations:***

#### **RACE 1 – MCKENZIE/CLARKE MEMORIAL CLASS A HCP– 1400 METRES**

EX WORDS (R Mangan) – Slow into stride.

MR MONARCH (J Luxe) – Slow into stride. Raced three wide throughout the early and middle stages. Layed in in the home straight.

JUDGE BURNS (M Ulcinar) – Layed in in the home straight.

#### **RACE 2 – VORTEX AIR GALLOP PLATE CLASS A HCP– 1200 METRES**

The all clear to this event was delayed when rider R Mangan (VALCURL), requested to view the official photo finish.

Rider D Schmitt (DASHING DEVON) and Trainer J Taylor requested to view the official patrol films in relation to alleged interference in the home straight. After viewing the official patrol films, both rider and trainer elected not to lodge a protest and correct weight was declared on the judge's numbers.

DASHING DEVON (D Schmitt) – Inconvenienced when checking off the heels of Kovello in the home straight.

THE WICKED WITCH (J Philpot) – Slow into stride.

KOVELLO (J Luxe) – Slow into stride. Shifted in in the home straight, resulting in Dashing Devon checking off heels. Shifted in nearing the winning post.

Stewards inquired into the reason why Dashing Devon had to check off the heels of Kovello in the home straight. After taking evidence from rider J Luxe, Stewards were of the opinion that J Luxe allowed his horse to shift in when insufficiently clear of Dashing Devon (D Schmitt). Mr Luxe was issued with a severe reprimand under the provisions of AR137(a) for careless riding.

#### **RACE 3 – TRT PASTORAL CLASS B HCP– 1000 METRES**

No racing incidents to report.

#### **RACE 4 – MACCALLUM INGLIS CLASS B HCP– 2600 METRES**

SHIVIDA (A Bryan) – Saddle slipped rounding the home turn on the first occasion resulting in this gelding becoming intractable.

STANFIELD CARUS (R Mangan) – Slow into stride.

BRONX TALE (J Luxe) - Slow into stride.

#### **RACE 5 – COL COTTER MEMORIAL CLASS B HCP– 1600 METRES**

SEBRING STAR (D Schmitt) – Shifted out and bumped with Take On Me at approximately 700 metres.

TAKE ON ME (M Ulcinar) – Bumped with Sebring Star at approximately the 700 metres.

JIMENA (A Bryan) - Fractious behind the barriers and subsequently difficult to load.

#### **GENERAL**

Stewards spoke with Trainer Mrs P Mallison in relation to her training practices recently at the King Island track whilst working horses. Mrs Mallison was reminded of her obligations when working horses at the track to ensure she is aware of all rules and furthermore that failure to abide by these rules may result in charges and penalties being issued in future.
