Approaching the home turn Breaker Upper checked off the heels of Tilly Lee checking Wynburn Ava and Tilly Lee. Soon after Wynburn Ava and Blackwood Tugen bumped.

Our Magic Molly has been stood down from racing for a period of 21 days.

The all clear in this event was delayed for Stewards to review the official patrol films and speak with lure driver Mr W Ivory in relation to the lure and the distance from the leading greyhound. In particular rounding the home turn. Acting on their own observations and viewing the official patrol films Stewards were satisfied that as a consequence of such variants no greyhound was substantially inconvenienced so as to effect the outcome of the event and all clear on the Judges numbers was given. My Bro Zorro and Wynburn Phoenix were slow out. Soon after the start Fasika, Rewind's Return and Slingshot Sambo bumped. In the back straight Hartley Kris, Fasika, Rewind's Return and Slingshot Sambo bumped checking Fasika. Soon after Da Bont and Wynburn Phoenix bumped. On the first turn Fasika crossed to the rail checking Da Bont and Wynburn Phoenix. Soon after Hartley Kris and Rewind's Return bumped checking both greyhounds. Approaching the home turn My Bro Zorro galloped on the heels of Hartley Kris checking both greyhounds. As a result Hartley Kris, Rewind's Return and Fasika bumped checking Hartley Kris and Fasika. On the home turn Wynburn Phoenix and Rewind's Return bumped. Hartley Kris and Fasika raced wide in the home straight.

Walla Wuti and Gee Rich were slow out. Soon after the start Major Mint and Gee Rich bumped. In the back straight Kreuzberg, Winklee Terror and Midnight Swim bumped checking Winklee Terror. On the home turn Miller's Sock and Winklee Terror bumped checking Miller's Socks. Soon after Walla Wuti and Gee Rich bumped on several occasions checking Gee Rich. Kreuzberg raced wide on the home turn and in the home straight. Miller's Socks underwent a post-race veterinary examination and was found to have minor spike wounds to the left hind webbing, however no stand down period was applied. A post-race swab sample was taken from Dancing Barefoot winner of the event.

In the back straight Outa Manilla and Miss Me Knot bumped. Soon after Miller's Cove and Minor Magic bumped. Approaching the first turn Miller's Cove, Miss Me Knot and Outa Manilla bumped checking Miss Me Knot. Soon after Minor Magic, My Boy Roman and Snowball Emma bumped checking Snowball Emma. As a result Miss Me Knot checked off the heels of Snowball Emma. Miss Me Knot underwent a post-race veterinary examination and was found to have lower back soreness. Miss Me Knot has been stood down for a period of 10 days.

#### **General:**

Toss The Dice completed a Stewards satisfactory trial as it had been stood down from the Ballarat Greyhound Racing Club on the 30/12/18 for failing to pursue the lure with due commitment throughout the event pursuant to GAR 69(A)(1). Weighing 31.6 kg and beginning from box 3 Toss The Dice completed the 452m trial distance in a time of 25.90. Toss the Dice has been cleared to race at all tracks except Bendigo and Ballarat.
