Millie Magna underwent a post-race veterinary examination and no apparent injury could be detected. Giamatti underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr E Haldane in relation to the racing manners of Giamatti approaching the first turn. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Giamatti had

turned its head outwards and made head or muzzle contact with Millie Magna and by doing so had marred the running of that greyhound pursuant to GAR69(1). Acting under the provisions of GAR69(2)(a), Giamatti has been stood down from racing for a period of 28 days Hobart only and until the completion of a satisfactory trial.

Approaching the home turn, My Girl Margie, Northern Tattoos and Giant Valley bumped, checking Giant Valley. On the home turn, Northern Tattoos and My Girl Margie bumped, checking My Girl Margie. Monahan Lass and Giant Valley raced wide in the home straight. Giant Valley underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Ozzi Oscar, winner of the event.
