Lucky Eight completed a Stewards satisfactory trial as it had been stood down from the NWGRC meeting on the 1st of February 2019 for marring pursuant to GAR69(1) . Weighing 30.9 kg and beginning from box 5, Lucky Eight completed the 452m trial distance in a time of 26.13. Lucky Eight has been cleared to race at all tracks.

Landlord completed a Stewards satisfactory trial as it had been stood down from the HGRC meeting on the 2nd of May 2019 for displaying signs of hypoxia pursuant to GAR74(1). Weighing 34.5 kg and beginning from box 3, Landlord completed the 452m trial distance in a time of 25.59. Landlord has not been cleared to race as the greyhound showed signs of cramping.
