Painted Banjo underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its left triceps muscle and lacerations and abrasions to both front feet. Painted Banjo has been stood down from racing for a period of 7 days. Dunking underwent a post-race veterinary examination and no apparent injuries could be detected. Bridge Of Hylia underwent a post-race veterinary examination and no apparent injury could be detected. Bridwood Marshal underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its right shoulder. Bridwood Marshal has been stood down from racing for a period of 3 days.

On the home turn, Fiery Peta and Destini Duchess bumped, checking Destini Duchess. Clunes underwent a post-race veterinary examination which revealed the greyhound to have muscle soreness to its left and right tensor fascia muscles. Clunes has been stood down from racing for a period of 7 days. Tah Bob underwent a post-race veterinary examination and no apparent injury could be detected. Decisions underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Fiery Peta, the winner of the event.

Arcadian Bandit completed a Stewards satisfactory trial as it was stood down from the LGRC meeting on the 6th of May 2019 for failing to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Weighing 31.3kg and beginning from box 3, Arcadian Bandit completed the 278M trial distance in a time of 16.18. Arcadian Bandit has been cleared to race at all tracks.

Spring Gully Gem completed a Stewards satisfactory trial as it was stood down from the NWGRC meeting on the 12th of March 2019 for failing to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Weighing 27.0 kg and beginning from box 5, Spring Gully Gem completed the 278M trial distance in a time of 16.70. Spring Gully Gem has been cleared to race at all tracks except Devonport up to the distance of 340M.
