RACE 1 – THE ADVOCATE – GRADE 6(1) – 452M

In the back straight, Leprechaun Dance and Mecca Senior bumped. Approaching the first turn, Willy Bound and Mecca Senior bumped, checking Mecca Senior. Soon after, Atley Quick checked off the heels of Leprechaun Dance.

RACE 2 – SUREPICK – GRADE 6(2) – 452M

Stylish Dash went up with the lids. Blackwood Polly was slow out. Soon after the start, Minish Woods and Hello Curly bumped. In the back straight, Minish Woods and Hello Curly bumped. In the back straight, Minish Woods stumbled. Approaching the first turn, Stylish Dash galloped on the heels of Faron Wood, checking both greyhounds. On the home turn, Faron Wood and Stylish Dash bumped. Soon after, Got The Edge, Stylish Dash and Faron Wood bumped. Hello Curly raced wide rounding the home turn.

RACE 3 – DOWLING MCCARTHY TYRES – GRADE 5(1) – 452M

Buckle Up Laura was slow out. Soon after the start, Miss Payne checked off the heels of Abella's Spirit. Approaching the first turn, Loco Queen, Abella's Spirit and Jellybean Jones bumped, checking all three greyhounds.

RACE 4 – ULVERSTONE PET FOODS – GRADE 5(2) – 452M

County Psycho, Gee Rich and Stefan's Choice were slow out. Soon after the start, Yes Scottie, Stefan's Choice and Country Psycho bumped. In the back straight, Yes Scottie and Stephan's Choice bumped, checking Stefan's Choice and Country Psycho, at the same time Koko and Abbella Magic bumped, checking both greyhounds. Approaching the first turn, Hardaway Zoe checked off the heels of Koko. In the home straight, Yes Scottie and Abbella Magic bumped. Approaching the winning post, Yes Scottie and Abbella Magic bumped on several occasions. Country Psycho underwent a post-race veterinary examination and no apparent injury could be detected. Stefan's Choice underwent a post-race veterinary examination which revealed the greyhound to have neck pain to the left and right sides. Stefan's Choice has been stood down from racing for a period of 7 days. A post-race swab sample was taken from Buckle up Ava, the winner of the event.

RACE 5 – CARLTON DRAUGHT – GRADE 4(1) – 452M

Hello Lenny, Dahlhaus and Buckle up Nola were slow out. Soon after the start, Rivenlee Lad, Hello Lenny and Prince Fabio bumped, checking Hello Lenny. Approaching the first turn, Hello Lenny checked off the heels of Rivenlee Lad. As a result, Dahlhaus checked off the heels of Hello Lenny. Approaching the home turn, Hello Lenny and Buckle Up Nola bumped, checking Buckle up Nola. Soon after, Drop The Leash checked off the heels of Rivenlee Lad. Rivenlee Lad and Drop The Leash bumped on several occasions in the home straight. Approaching the winning post, Rivenlee Lad and Drop The Leash bumped. Soon after, Drop The Leash and Dancing Barefoot bumped. Hello Lenny underwent a post-race veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Drop The leash, winner of the event.

RACE 6 – SYECTIC DEVONPORT – GRADE 4(2) – 452M

The all clear in this event was delayed for Stewards to review the official patrol films and speak to lure driver Mr W Ivory in relation to the lure, in particular rounding the home turn and entering the home straight. Acting on their own observation, viewing the official patrol films, Stewards were satisfied that as a consequence of such variance in the lure speed no greyhound had been substantially inconvenienced so as to affect the outcome of the event and all clear on the judges numbers was given.

My Mum Elyce was slow out. Soon after the start, Muppet, My Mum Elyce and Spirit Flame bumped, checking Spirit Flame. Approaching the first turn, Muppet and Benky Bomber bumped. Soon after, Benky Bomber and Millie Magna bumped, checking Benky Bomber. On the first turn, Spirit Flame and My Mum Elyce bumped. On the home turn, Benky Bomber and Millie Magna bumped, checking Millie Magna. As a result, Millie Magana

and Da Bont bumped. In the home straight, Millie Magna checked off the heels of Da Bont. Spirit Flame and Benky Bomber bumped on several occasions in the home straight.

RACE 7 – CUSTOM RESOURCES & RECRUITMENT – MIXED 2-3 – 452M

Soon after the start, Rewind's Return, Kayda Affair and Reiki Master bumped. Soon after, Irinka Bay and Buckle up Clint bumped, checking Irinka Bay. Approaching the first turn, Irinka Bay galloped on the heels of Buckle up Clint, checking both greyhounds.

RACE 8 – CITY OF DEVONPORT CUP – BEST 8 – 452M

Buster Emery was slow out. Soon after the start, Peco Can and Santa Claws bumped. In the back straight, Posh Amber and Hoity Toity bumped. Approaching the first turn, Santa Claws, Hello Nugget, Hoity Toity and Posh Amber bumped, checking all four greyhounds. Soon after, Posh Amber checked off the heels of Santa Claws. A post-race swab sample was taken from Stop Line, the winner of the event.

RACE 9 – SIMON'S CARPET ONE – GRADE 5(3) – 452M

Jack's Whirl and Buckle up Carter were slow out. Soon after the start, Pamplona and Surrender bumped, checking Pamplona. Soon after, Surf A Lot and Jack's Whirl bumped. In the back straight, Buckle Up Carter and Jack's Whirl bumped. Approaching the first turn, Jack's Whirl and Buckle Up Carter bumped. Soon after, Mountain Miss checked off the heels of Surrender. As a result, Mountain Miss and Pamplona bumped, checking Pamplona. In the home straight, Surf A Lot checked off the heels of Pamplona. Pamplona underwent a post-race veterinary examination and no apparent injury could be detected.

RACE 10 – CROWN LAGER – AUSTRALIAS BEST – GRADE5(4) – 452M

Spring Gully Gem, Gold Drift and Miss Paw Paw were slow out. Soon after the start, Toss The Dice, Gold Drift, Miss paw Paw, Bekim Express and Double Truth bumped, checking Gold Drift and Miss Paw Paw. In the back straight, Spring Gully Gem and Double Truth bumped. Approaching the first turn, Bluegrass Moss and Outa Manila bumped checking both greyhounds. Soon after, Bluegrass Moss checked off the heels of Outa Manila. As a result, Spring Gully Gem, Bluegrass Moss and Outa Manila bumped, checking all three greyhounds. On the home turn, Gold Drift, Bluegrass Moss and Miss Paw Paw bumped. Soon after, Toss The Dice and Double Truth bumped. In the home straight Bluegrass Moss galloped on the heels of Toss The Dice, checking Toss The Dice. A post-race swab sample was taken from Bekim Express, the winner of the event. Bluegrass Moss underwent a post-race veterinary examination and no apparent injury could be detected. Spring Gully Gem underwent a post-race veterinary examination which revealed the greyhound to have mild lower back soreness. Spring Gully Gem has been stood down from racing for a period of 7 days. Stewards spoke to trainer Mr M Johnson in relation to the race manners of Spring Gully Gem, in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Johnson. Stewards were of the opinion, that Spring Gully Gem had visibly eased, free of interference when leading the event in the home straight and by doing so had failed to pursue the lure with due commitment throughout the event by reason of injury, pursuant to GAR69B(1)(a). Spring Gully Gem has been stood down from racing for a period of 7 days and until the completion of a satisfactory trial.

General:

Blackwood Vegas completed a Stewards satisfactory trial as it had been stood down from the HGRC meeting on the 14th of February 2019 for failing to pursue the lure with due commitment throughout the event, pursuant to GAR 69A(1). Weighing 25.6 kg and beginning from box 3, Blackwood Vegas did not complete the 452M trial distance. Blackwood Vegas has not been cleared to race as it failed to finish the event. Blackwood Vegas underwent a post-trial veterinary examination and was found to have a left hind abductor injury. Blackwood Vegas has been stood down from racing for a period of 21 days.

Coningsby completed a Stewards satisfactory trial as it had been stood down from the NWGRC meeting on the 8th of September 2018 for failing to pursue the lure with due commitment throughout the event by reason of injury, pursuant to GAR69B(1)(a). Weighing, 30.2 and beginning from box 3, Coningsby completed the 452M trial distance in a time of 26.75. Coningsby has been cleared to race at all tracks.

CHAIRMAN OF STEWARDS
